



DRAGON'S VOYAGE OFFICIAL RULES

1. The Resorts World Dragon's Voyage ("Promotion") is a system delivered, randomly triggered floor-wide bonus that utilizes a 5 digit drawing that is played on slot machines for Genting Rewards members who are i) carded ii) playing at a slot machine with an active rating ("Participants").
2. It is the Participants responsibility to ensure their Genting Rewards card is properly connected to the slot machine.
3. Table games and non-gaming ratings will not qualify for this Promotion.
4. Participants must play on their own individual Genting Rewards card. Any participant violating or tampering with the Promotion in any way may be disqualified and declared ineligible for any award.
5. Upon registration into Genting Rewards, all Participants are randomly assigned five (5) random numbers (0-9). Participants may select a different variation of the five (5) numbers by carding into any slot machine and pressing the SuperSeries button on the machine display and selecting the numbers button. Participants will then be prompted to enter their PIN and may select new numbers (0-9) of their choice.
6. The Promotion is ongoing and active starting from 5:00 a.m. Tuesday, November 1, 2022 (the "Promotional Period").
7. During the Promotional Period, the entire slot floor will go into Dragon's Voyage mode at randomized times between 5:00 a.m. and 11:59 p.m. daily ("Activation Period").
8. Prior to the Activation Period, the system scans for active, carded Participants. During this time, changing denominations, changing game titles or certain bonus rounds may exclude a Participant from the Promotion.
9. During the Activation Period, slot machines with active, carded ratings will go into Dragon's Voyage mode. A dragon video will display where the dragon icon will draw five (5) random numbers (0-9) in sequential order.
10. To win the Promotion, the Participant's selected numbers will have to match the system generated numbers in the same position in which they are being drawn.
11. Free Play prizes will be awarded to Participants that match between two (2) and four (4) numbers in the correct position.
12. Progressive Jackpot is awarded upon match of all five (5) numbers in correct sequence. The Progressive Jackpot for a five (5) number exact match will be notified on the player's card display and an attendant will respond to verify win.
13. To redeem the cash award, winning Participant(s) must present valid photo identification that matches the name on the Genting Rewards card connected to the machine at the time the cash award is won.
14. In the event of a tie for the Progressive Jackpot, the tied Participants will equally split the sum total of the Progressive Jackpot.
15. The Prize Structures will be paid as published.
16. The Progressive Jackpot will be awarded in cash and the starting jackpot amount is \$50,000.
17. Upon awarding the Progressive Jackpot, the Progressive Jackpot amount will reset to \$50,000.
18. All Free Play prizes will be automatically loaded to the Genting Rewards member's account after the Activation Period.
19. All Free Play prizes will expire 180 days from date of distribution.
